



4 - Outlets











INSTRUCTIONS

Push up timer tabs (located at the edges of the timer dial) toward center of dial to turn yellow outlets on and blue outlets off. Push timer tabs down to turn blue outlets on and yellow outlets off. Each timer tab represents a 15 minute interval. The white outlets provide constant power controlled by the on/off switch. The on/off switch controls power to all outlets and the timer.

SETTING THE CLOCK


Set current time of day by turning timer dial clockwise until correct time faces arrowhead <





SETTING THE DAY-NIGHT TIMER

- 1. Turn manual control switch to timer-on (position. Be sure that clock is set to current time of day.
- Select time of day you want daytime lights turned on and push timer tabs up to turn on yellow outlets for daytime applications.
- Make sure timer tabs are up until you reach time of day when you want daytime lights turned off.
- 4. Nighttime timer is set by pushing timer tabs down to turn on blue outlets.

NOTE: Blue and yellow outlets alternate power; both outlets cannot be on at the same time (i.e. when nighttime blue outlets are on, the daytime yellow outlets are off).







MANUAL CONTROL

Bypass timer by using manual control switch. To activate yellow daytime outlets continuously, turn switch to yellow-on \bigcirc position.

To activate blue nighttime outlets continuously, turn switch to blue-on **1** position.

POWER CENTER INSTALLATION

- 1. Once time cycles are set, plug the light fixture power cords into the Power Center.
- 2. Turn on the Power Center On/Off switch.
